Background Check for Volunteers

Please keep this information for your records

Pursuant to the Minnesota Child Protection Background Check Act (Minn. Stat. §299C.60-299.64), Kick'n Up Kountry, Inc. may perform a background check to determine whether you are the subject of any reported conviction for a "background check crime".

As the subject of a background check under the Minnesota Child Protection Background Check Act you have the following rights:

- To be informed that Kick'n Up Kountry, Inc. will request this check before assuming the duties of or continuing as a volunteer in order to determine whether you have been convicted of any crime listed in § 299C.61, subd. 2 or 4 (listed on back)
- To be informed by Kick'n Up Kountry, Inc. of the response to the background check, and to obtain a copy of the background check report
- To obtain from the Superintendent of the Bureau of Criminal Apprehension any record that forms the basis for the report
- To challenge the accuracy and completeness of any information contained in the report or record, pursuant to Minn. Stat. §13.04, subd. 4
- To be informed by Kick'n Up Kountry, Inc. if your applications or continuation as a volunteer has been denied because of the response to the background check
- To not be charged directly or indirectly for the cost of the background check

Data privacy requires that we inform you that you do not need to provide this information. However, if you choose not to provide information, Kick'n Up Kountry, Inc. may no longer consider your application. Any omission or false representation may result in rejections of your application. Any omission of false representation may result in rejection of your application, or in the termination of your position.

If your back ground check shows you have a conviction that excludes you from working with children and vulnerable adults, you will receive a letter which disqualifies you as a volunteer candidate. The letter also outlines an appeal process. You will have 30 days in which to submit a letter and relevant information in order to be reconsidered for a volunteer position. If you are already volunteering for Kick'n Up Kountry, Inc. and your background check reveals a conviction, you will be immediately dismissed from your position.
